IV. AB109 Data Dashboard/Split v. Straight Sentences

- a. ADCPO Leslie Brown presented the Data Dashboard (Dec '22 - Feb '23) and
- b. Split v. Straight Sentence Data (Dec '22 - Feb '23).
There was one clarifying question asked and answered.

V. AB109 Year 10 Annual Report (Data Co-Op)

- a. Stephanie Waldron and Natalie Garcia from Data Co-Op presented the information from the provided report. Clarifying questions were asked and answered.

VI. Review and Approval of Budget Modification

- a. Mary Magdalene Community Services
DCPO Wilder requested Geneva Haynes to present the budget modification request that went before the AB109 Oversight Committee. It was then presented by their Accountant Christopher McKinnon: no budgetary increase, simply a reallocation of funds into Rental Space and Utilities from a total of 6 other line items. Clarifying questions were asked and answered.
Motion: Approve the Budget Modification Request. Motion was approved.

VII. Review and Approval of Program Enhancement Request

- a. Correctional Health Services
DCPO Wilder introduced Lori Cyr to present the request that went before the AB109 Oversight Committee. Ms. Cyr shared contracted salaries with SIEU and CNAs were in negotiations this time last year and therefore increases that began in July '22 were not budgeted; they are requesting additional funds of \$120,152 to their salaries. There were no questions or comments.
Motion: Approve the Program Enhancement Request. Motion was approved.

VIII. Review and Approval of One Time Request

- a. Correctional Health Services
Lori Cyr presented the request that went before the AB109 Oversight Committee. CHS is requesting \$22,365 to cover the cost of a required medication for a client. Clarifying questions were asked and answered.

IX. Review and Approval of FY 2023-2024 CCP Budget Proposals

X. Other Updates

MAIII Rigo Ochoa provided an update regarding the RFI/RFP process. The process has begun with the County's Purchasing & Support Services Department, hoping to have it online in the next few weeks. Encouraged agencies to register with said department in order to obtain and receive information as well as submit proposals.

XI. Public Comment

San Joaquin County Office of Education, Doug McCreath, shared information related to Come Back Kids; a program offering adults 18 years and older, a high school diploma. The independent study program is WASC accredited and takes approximately 6-8 months to complete. Fill out their interest form to get started with enrollment.

Community Partnership for Families, Edward King, shared the next tattoo removal event will be held in April, exact date TBD.

Family Legacy, San Juana Melgoza, introduced Family Legacy who offers a sex offender treatment program geared towards youth offenders.

Health Care Services, Greg Diederich, shared Behavioral Health Services (BHS) are finishing up their stakeholder engagement for the Mental Health Services Act 3 year plan. It will go to the BHS Board Meeting at the end of April which will then be presented to the Board of Supervisors in June. Also, the National Opioid Settlement funds are starting to flow. HCS are charged with bringing a plan to the board for expenditure use dedicated to expanding substance abuse treatment. They are looking to move from a social to a medical model for detox, community engagement is needed.

District Attorney's Office, Ron Freitas, discussed the One Pill Kills campaign, discussed dangers and is proposing overdose as the number one health concern. He also shared that the no cost 3 week Youth Leadership Academy is now accepting applications (open to all high school students) via his office's website. It is an opportunity to look at the criminal justice system. Also looking for those who have gone through the program to come back and be youth leaders.
