## IV. Review and Approval of Program Enhancement Request

SAN IOAOUIN COUNTY -

a. Probation – AB 109 Administrative Services
DCPO Wilder presented the request that went before the AB 109 Oversight
Committee. The request is to purchase a new model of tasers which probation officers
within the AB 109 division would use as the current model will no longer be
supported beyond March 2024. There were no questions or comments.
Motion: Approve the Program Enhancement Request. Motion was approved.

## V. Review and Approval of:

a. Presentation of RFI Results

MAIII Rigo Ochoa shared the RFI posted in May returned 16 general submissions from 11 different vendors including 7 from agencies that Probation has not worked with previously. There was at least 1 submission for all 6 requested categories (Incustody Programs and Services, Housing Assistance, Work/Vocation Programs, Programs for Families, Programs for Women, and Pro-Social and "Other" Innovative Programs). The submissions provided an indicator for how much programs/ services cost and how much funding should be allocated for new programs. This request also provided information as to what categories of procurement can be used (MOU can be created for inter-department county agencies while unique services do not require a competitive bid). Two proposals were received from county agencies: San Joaquin County Office of Education and a joint proposal from Behavioral and Public Health Services.

### b. RFP Recommendation

MAIII Rigo Ochoa then discussed, based on the RFI results, that there are services and vendors that can meet additional needs of clients. He discussed a recommendation that 1 RFP be submitted to allow proposals from each of the 6 categories and \$6 million should be allocated for new programs. Clarifying questions were asked and answered.

Motion: Approve the submittal of an RFP for programs to not exceed \$6 million. Motion was approved.

c. Formation of New Subcommittee

MAIII Rigo Ochoa presented the recommendation to form a new subcommittee as the AB 109 Subcommittee formed as a result of the December 2021 CCP has successfully met its purpose of identifying needs of the AB 109 population. The purpose of this new subcommittee would be to continue to communicate and discuss programs, services, efficiency, advise the Executive Committee, and provide an avenue for the Executive Committee Members to assign tasks and fill gaps as needed. Clarifying questions were asked and answered.

Motion: Approve the formation of a new subcommittee. Motion was approved. (Jackson / Freitas / 7 / 0)

d. CCP Pilot Program – Beyond Barriers (The Uplift All Foundation)
MAIII Rigo Ochoa presented the Beyond Barriers – Comprehensive Reentry

uniqueness of this program, no competitive bid is required, therefore a formal
proposal was submitted for funding. Clarifying questions were asked and answered

A report will be made available and used to approach the BOS on ways HCS can take a larger leadership position on homelessness within the county. The job offer is being finalized for Adam Chesire's replacement. Mr. Diederich has been appointed interim CEO for San Joaquin Health.
