- b. Geneva Moorad presented for Bridges of Hope. Currently there are 5 houses with 24 hour staffing. Services include transitional housing, job readiness, career workshops, and mental health support. They also assist with getting social security cards, welfare benefits etc.. Only qualification is that they receive MediCal.

Erika Nunez announced to the group that there was a Teen Dating Violence Awareness event at Cesar Chaves HS on 2/19/2025 from 4:30 - 7:00 pm.

Chief Jackson recognized the young men here who are an example and are setting the standard for other young men in the community. Thank you for being here.
