- A. Discussion of the Proposition 47 grant funding that has been awarded to Friends Outside and Office of Violence Prevention that offers diversion in a pre-plea way
  - i. Grant is for mild/mod behavioral health folks and substance use treatment
  - ii. Will create a diversion program called Redirect (program supervisor, 2 peacekeepers) consisting of mentorship from OVP, MBSAT (mindfulness-based substance abuse treatment), wellness retreat at Big Trees
    - 1. Also wrote into the grant that families can be referred to Friends Outside, behavioral health, etc. for support
    - 2. Client Success Team (CST) meetings (like CFTs)
    - 3. Referrals can come from schools and family members. They don't need current charges. Former charges can also qualify them for the program.

  - 1. ALL graduates are enrolled into college courses going towards their AA degrees
  - 2. Most graduates enrolled into multiple courses
  - 3. College courses start tomorrow 1/9 and Saturday 1/10 with a few courses having a later start date
- ii. Students
  - 1. ALL students are enrolled in full schedules moving towards their HS diplomas
  - 2. A few students are close to graduating and will be dual enrolled into a college course once they get close to graduation
- iii. CTE/ArtTherapy
  - 1. ALL students receive Art Therapy at least twice a week as of right now with two artists coming into the facility Monday-Friday
  - 2. Gratitude Art Show was a huge success with the most students qualifying up to this point. We have been doing these shows for 3 years and we had over 20 students qualify with great behavior and the desire to show their art.
  - 3. Ethnic Studies theme of Cultivating Hobbies and Passions ended with a presentation held during the Gratitude Art Show.
  - 4. The 3rd quarter theme for the facility is Fostering a Supportive Social Circle. Education staff will be covering Social-Emotional Learning lessons every Monday and Friday directly connected to this theme.
  - 5. The logistics program continues to grow with a contest in the future that I will share more about at a later meeting once the contest is rolled out.
  - 6. Culinary continues to cook....PUN Intended
- iv. Positive Behavior Interventions and Supports (PBIS)
  - 1. The overarching theme of "Embracing Positivity" has been infectious with an Expectations Matrix of Safety, Accountability, and Positivity as the underlying components moving forward. More to come....
  - 2. Classroom lessons are currently being cultivated for all staff to begin teaching focused on Safety, Accountability and Positivity by the end of the school year.
