A. Commissioner Vacancies

- i. Updated on these notes to align with the bylaws, which have 13 individuals on the JJDPC. Our current openings include: 2 board nominated vacancies, 3 direct application vacancies, 2 youth vacancies

VIII. Juvenile Justice Commission Reports

A. Juvenile Court

- i. Working on setting first rounds of cases to terminate probation after 1 year (although the law does not go into effect until 1/1/2026).
- ii. Judge continues to advocate for gun/gang violence programming and substance use residential treatment programming for youth.

B. Chief of Probation

- i. Working on legislation compliance (1376, known as “forever probation” law)
 - 1. 47 kids are up for automatic dismissal in January
- ii. Congratulations to the detention division for their excellent inspections

C. Health & Human Services

- i. Partnered with National Center of Missing and Exploited Children and are now having monthly meetings to discuss how to engage youth who are absent from care
- ii. Quarterly meetings with leadership from probation, currently preparing for transitions related to the 1376 legislation
- iii. Expansion of drug court for non-minor dependents, and there is work to expand this to minors

D. Mary Graham Children’s Shelter

- i. Director is in training today and not present
- ii. Under 20 children – census has been around this recently

E. San Joaquin County Office of Education

- i. Recent release where student is attending Sacramento State
- ii. Attendance is 95-98%
- iii. Fall semester is ending for college students; most, if not all, are registered for Spring 2026 courses
- iv. Event next week connected to an art show connected to gratitude; 24 students are still eligible for the art show

 - ii. See every youth at least 1x, over 650 per year, and they work with the higher risk or need youth with consistency
